# 1 Purpose of this Document & Conventions

These General Terms & Conditions are designed to be referenced by other contractual documents and don't constitute an agreement by themselves. Instead, they define terms and conditions for a number of licenses (Chapter 2, Product & Licenses) and services (Chapter 3, Services) provided by [project-open[ to you.

In this document we use Capitalized words to refer to legal terms defined in this document, and to use *italics* when defining a new legal term.

Customer refers to the customer specified in the referencing document, while the words <code>]project-open[, ]po[, Provider, Supplier</code> refer to <code>]project-open[</code> Business Solutions, S.L.

#### 2 Product & Licenses

The ]project-open[ product consists of a software that consists of individually installable and licensable software "packages" listed in detail in Appendix C. Each software package is covered by one of the following licenses:

#### 2.1 License Types

2.1.1 Software Packages under GPL V2 License:

Most packages in the ]project-open[ Product are covered by the "GNU Public License V2 or Higher". The terms of the GPL V2.0 are defined in http://www.gnu.org/licenses/gpl-2.0.html. Basically, GPL V2 software is free for everybody to use, modify and redistribute.

2.1.2 Software Packages under GPL V3 License:

Some the ]po[ Product packages are governed by the GPL V3 license. The terms of the GPL V3 are defined in http://www.gnu.org/copyleft/gpl.html. Basically, GPLed software is free for everybody to use, modify and redistribute.

2.1.3 Software Packages under ]po[ Free License ("FL"):

Please see Appendix A for the definition of the FL license. Basically, FL'ed software is free for everybody to use and modify. However, redistribution is restricted to ]po[ partners.

2.1.4 Software Package under po[ Commercial License ("CL"):

The terms of the CL are defined in Appendix B. Basically, CL'ed software is "regular" commercial software in the sense that Customer has to pay for it. However, Customer



receives the source-code of the packages together with the right to modify the software for internal use. CLed packages are provided to Customer as part of the Professional and Enterprise Editions of the po[ Product.

#### 2.2 Product Editions

The ]po[ Product is provided in three *editions* that differ in terms of the included packages. For more details on the licensing of the packages provided in each Edition please refer to Appendix C.

#### 2.2.1 po[ Community Edition (CE)

The ]po[ community edition consists of a set of licensed under the GPL V2 and FL. It covers a large variety of processes, including Project Planning, Project Portfolio Management, CRM, Financial Controlling and Timesheet Management. This edition is designed with small and medium-sized enterprises in mind and available free of charge.

# 2.2.2 ]po[ Professional Edition (PE)

The ]po[ professional edition contains all packages provided by the ]po[ Community Editions plus packages that provides Financial Reporting and Data Warehouse Reporting. Typical users of the Professional Edition include service and consulting companies.

#### 2.2.3 po[ Enterprise Edition (EE)

The ]po[ *enterprise edition* is targeted for the use in large enterprises. It contains all Packages provided by the ]po[ Professional Edition plus packages specifically targeted to Enterprise clients.

# 2.3 Users and Customer Organization Definitions

Named User: Named Users include any natural person having access to Product. Named Users also include software applications or processes that connect to Product by means of a user name and a password or token. Named Users can be either Internal Users or External Users, as explained further below.

Customer Organization: Customer Organization is the organizational entity (enterprise, business unit, subsidiary, department, team, group of people work group, team) that uses Product to manage its business affairs.

External User: An External User is a Named User who is a natural person and:

- a. Is employed by a customer of the Customer Organization or
- b. Is employed by a provider of the Customer Organization.

Internal User: Any Named User who is not an External User.



# 2.4 Environments: Production vs. Testing, Backup or Development

Environment: A copy of the ]project-open[ product together with a Web server, a database and support software on a computer or any other virtual machine. An Environment does not include network infrastructure, backup devices or customer related systems (client PC, Web browser etc.).

*Production Environment*: An Environment used by at least one Named User with data describing a real-world business environment.

Development Environment: An Environment used exclusively by software developers and testers in order to develop modifications or extensions for the Production Environment.

*Test Environment*: An Environment used exclusively by software developers and tester in order to test the correct operation of modifications to the Production Environment.

Backup Environment: An Environment exclusively used in case of a technical failure in a Production Environment.

*Production Data*: The data about business affairs contained in the database of the Production Environment.

*Testing Data*: Testing Data is artificially created by software developers or tester and does not refer to Customer's business affairs.

The databases of the Development, Test and Backup Environments may not contain data about business affairs apart from Production Data. The environment may contain testing data in addition to Production Data. Otherwise the Environment is to be considered a Production Environment.

#### 2.5 Types of Product Modifications

Almost every ]project-open[ Environment requires some modification with respect to the originally released Product Versions. There are different types of modifications:

Modifications refer to any change in an Environment released by Provider including:

- TCL code (including ADP pages)
- JavaScript libraries and CSS
- SQL data-model and plpg/SQL procedures
- Code and configuration of operating system, database, proxy servers, etc.



Customizations refer to changes to the TCL code, the SQL data-model or plpg/SQL procedures of the Product.

Configurations refer to changes performed using any of the ]po[ pages in the Admin menu.

#### 2.6 Software Versions

*Product version*: ]project-open[ releases new versions of the Product from time to time and publishes information about these versions on it's Web site.

#### 2.6.1 Stable Version

Stable version (also called "Final Versions") is an officially released version that went through ALPHA and BETA testing and that is considered to be stable and ready for production.

#### 2.6.2 Released Version

Released version can be an ALPHA or BETA version or another release made on customer request and published on the pol Web site.

#### 2.6.3 Customized Version

Customized version refer to a Released Version with customer specific Customizations:

- · Customizations performed by Provider or some of it's agents or
- Customizations by Customer or 3rd parties that have been approved by Provider in a separately agreed approval process.

#### 2.6.4 Customer Modified Version

Customer modified version refers to a Released Version with modifications by Customer or a 3rd party without approval by Provider. Provider in general refuses to support Customer Modified Versions, unless agreed otherwise.

#### 2.6.5 Product Version Number

A *Product version* refers to a specific state of the Product in the ]project-open[ version control system. Product Versions are labeled with a *Product Version Number* that typically consists of 5 decimal digits separated by full stops (for example "4.0.4.0.2").



# 3 Service Types

The term *services* refers any of the following services provided by the ]project-open[ team and it's subcontractors.

#### 3.1 Installation Services

Installation services refer to system administration activities in order to allow the project-open[ software to perform its purposes in a networked or Internet environment.

The successful installation of the ]project-open[ Product requires access to a server equipped with a suitable operating system and database. The customer has the obligation to provide a suitable environment and adequate access to Provider.

- A server computer with at a CPU and I/O subsystem suitable to handle the work load planned as part of the a "sizing" process. The server needs to run one of the operating systems supported by [project-open[.
- The ]po[ team needs to access TCP port 22 (SSH) of the server computer in order to provide services remotely. More complex access methods (VNC, customer specific VPN or the use of specific gateways) need to be agreed upon.

#### 3.2 Configuration Services

Configuration services refer to the introduction of parameters, permissions and master data into a ]project-open[ environment in order to adapt the behavior to the structure of the Customer's organization.

For a successful configuration, the customer needs to provide reasonable information about his company to project-open[.

#### 3.3 Customization Services

Customization services refer to the modification of functionality of the [project-open] software in order to adapt it to specific Customer requirements.

The intellectual property of these changes remain with the Provider except specified otherwise due to the open-source nature of ]project-open[. <customer> enjoys for the same reason a nonexclusive right to use, modify and redistribute the customized software according to the terms of the software license governing the customized software package (see Appendix C).



# 3.4 Data Migration or Master Data Import Services

Data migration services refer to activities in order to load/import existing Customer data into project-open[.

For a successful data migration, the customer needs to provide all data to migrate in a suitable and consistent format (for example XML, CSV or via SQL access). Also, the ]project-open[ team needs online access to the existing system and its database when data are to be transferred from a legacy application.

#### 3.5 Installation of Security Patches

*Installation of security patches* refers to periodic updates of the ]po[ Product that are relevant to the security and integrity of a production environment.

#### 3.6 Preventive Maintenance Service

Preventive maintenance refers to the tracking of certain system parameters that indicate the need for maintenance before an actual error occurs. Examples include the available space on the hard disk, memory consumption, etc.

# 3.7 Product Upgrade Service

*Product upgrades* refers to upgrading the code of Product running in customer's Production Environment from one Product Version to a higher Product Version.

*Minor upgrades* refer to an Upgrade to the next minor version number (the 2nd digit in a Product Version), such as V3.1 -> V3.2.

*Major upgrades* refer to an Upgrade to the next major version number (the 1st digit in a Product Version), such as V3.5 -> V4.0.

If the Customer modifies the Product code, Product Upgrades may not function correctly or there may be errors. These errors are not considered to be Product Defects.

# 3.8 Correction of Errors ("Bug Fixing")

Product defects are:

- a) defects are clearly identifiable as such and result in a ]project-open[ "Report this Error" screen or
- b) a behavior of Product that deviates in material respects from their functional specifications in the documentation at www.project-open.org.

*Product defect correction* refers to the service to correct Product Defects in the Product reported by Customer. The Incident Severity of Product Defects is determined according to section 3.5.



Supplier is not obliged to correct Product Defects if Customer has modified the Product code, unless agreed otherwise.

*Errors* refer to misbehavior of an environment perceived by users. Errors include Product Defects, but may refer to misbehavior cause by the configuration of the product and other sources.

Features and Enhancements refer to system behavior reported by Customer that is not provided by the Product Version installed at Customer's Production Environment. *Incidents* refer to Errors, Features and Enhancements reported by Customer using the Ticket Tracker.

#### 3.9 Recovery Services

Recovery services refer to the restoration of a production environment from a previous backup. Customer agrees to provide ]project-open[ with complete backups in order to provide Recovery Services.

#### 3.10 Training Services

*Training services* refers to training session of senior management, project managers, accounts and system administrators.

For a successful training, it is recommended that Customer provides the parties to be trained with sufficient slack time and reassurance of the value of the training time.

#### 3.11 Consulting Services

Consulting services refer to any consulting services provided by a consulting, including the services above.

#### 4 Service Terms Definitions

#### 4.1 Service and Support Channels

Remote support is provided remotely by phone, email or chat messenger (SKYPE, IRC). When on-site support is required, additional costs for travel and accommodation do apply.

#### 4.2 Service Time

Service time refers to the amount of time required by ]project-open[ to react to an incident and to resolve the incident.



Service Time is logged by ]project-open[ and its agents into a timesheet system with a granularity of ½ hour for every ½ hour started. When Service Time is billable to customer, a detailed list of Service Time is provided to Customer with each invoice.

#### 4.3 Service Hours

Service hours refers to the business hours of ]project-open[ during which services are provided as specified below:

8h/5d refers to business hours from 9:00 am to 5:00 pm- from Monday to Friday, except the bank holidays in Barcelona, Spain.

12h/6d refers to business hours from 9:00 am to 9:00 pm from Monday to Saturday, except for New Year's Day (1.1), Good Friday (Easter Sunday-2d), Easter Monday (Easter Sunday+1d), Labour Day (1.5.), Ascension Day (Easter Sunday+39d), Whit Monday (Easter Sunday+50d), Christmas day (25.12) and St. Stephen's Day (26.12).

#### 4.4 Reaction Time

Reaction time refers to the time span starting after Customer has issued an incident in the <code>]project-open[</code> Ticket Tracker (defined in section Incident Reporting below) and the start of service activities by <code>]project-open[</code>.

#### 4.5 Solution Time

Solution time refers to the time span from the start of service activities until the restoration of the proper operation of the Environment.

#### 4.6 Incident Severity

Incidents are classified according to their impact on the Customer Organization:

- Job stopper errors or job stoppers: A Job Stoppers prevents a majority of the user of a system to perform their daily operations.
- Serious errors: Serious Errors affect the ability of individual users to perform daily operations while other parts of the system are still available.
- *Minor errors*: Minor Errors are errors that do not affect essential functionality of the system.

# 5 Service Billing Types

#### 5.1 Pay as you go (PAYG)

*PAYG* service is requested and provided ad-hoc. PAYG is based on the availability of a support engineer. The minimum purchase is one hour. Time not used expires 30 days after the provision of the first support unit.



# 5.2 Prepaid support

*Prepaid support* refers to a package of support hours purchased at a certain moment. Pre-paid hours will expire one year after purchase.

#### 5.3 Subscription based support

Subscription based support guarantees fixed response times as defined in a separate Service Agreement.

# 6 Payment Conditions

]project-open[ will issues invoices for Licenses and Services as agreed together with customer according to specific terms in a service contract.

Customer agrees to provide appropriate payment for the invoices issued by Provider. A delay of more then 30 days in payment beyond the invoice due date automatically leads to a suspension of services by Provider.

#### 7 Travel and Accommodation

]project-open[ will invoice travel costs to the customer, as agreed in a separate document.

Travelling consultants will receive allowances of €100 per consultant and night abroad. If travel time exceeds 4 hours, total travel time is billed based on the hourly consulting rate agreed. However, no more than one consulting day is charged for each single trip.

# 8 Performances by the Customer

The successful delivery of services depends on the collaboration with the customer. Therefore Provider will expect certain performances by the Customer:

#### 8.1 Decisions

This quotation is conditional upon the active participation of the Customer. The planned schedule requires that outstanding decisions should be taken quickly and finally and the available capacities and decision-making structures should be in place on the part of the Customer.



#### 8.2 Access

]project-open[ is dependent on diverse information and freedom of action within the Customer's infrastructure during the specified time for the successful implementation of the project. This includes the description and definition of necessary interfaces, knowledge of the infrastructure, acquaintance with and access to responsible contact partners and access to the necessary internal interfaces.

This quotation is based on the assumption that these basic requirements will be available in a form expedient for the project with respect to scope and time.

# 8.3 Incident Reporting

Depending on service contracted, ]po[ will provide Customer with self-service access to a *Ticket Tracker* application at http://www.project-open.net/ in order to allow Customer to enter service requests.

The Reaction Time service level parameter starts when an incident has been logged in the Ticket Tracker. Incidents from other channels such as email or telephone first need to be entered into the Ticket Tracker.

It is important that Customer provides Supplier with all necessary information in order to reproduce the incident. Required information includes the incident's URL, the active user, passwords necessary to access the Customer's system, a contact person on the Customer's side etc. Irreproducible incidents are not considered relevant for service level metrics.

#### 8.4 Active Collaboration

The customer's employees, subcontractors and other collaborators are key members of the project team and will need to collaborate efficiently and timely in order to ensure the success of the project. In particular, qualified personal should be available to operate local machines in the case of resolving issues via remote maintenance.

#### 9 Performances by the Customer in Case of Service Contracts

The following performances of Customer refer to hosting and service contracts where Jpo[ accepts the responsibility to run and maintain the Production Environment.

#### 9.1 No Interference with Operation of System

Customer agrees not to maliciously or intentionally interfere with the proper operation of the Production Environment and to adhere to industry best practices for maintaining the project-open system.



#### 9.2 Backup

Customer agrees to perform regular backups on backup medium suitable for recovery. It is customer's obligation to assure the completeness, security and consistency of backup data. The operation of backup procedures is not included in the offered services, unless otherwise explicitly stated.

#### 9.3 Security

Supplier takes reasonable measures to maintain the privacy and integrity of the data stored in a <code>]project-open[</code> Production Environment. However, Customer acknowledges that 100% security cannot be guaranteed in Internet systems. <code>]project-open[</code> cannot be held responsible for breaches in the system security, in any form.

#### 9.4 Administrative Access

If needed, customer provides ]project-open[ "root" access to the operating system and web access to the Production Environment over the Internet in order to perform Services.

# 10 Liability

]project-open[ will be liable for direct and indirect damage or other harm to property caused by its work at the Customer, the Customer's contractual partners or third parties if such damage is caused intentionally or by gross negligence. Further liability is excluded. ]project-open['s maximum liability will not exceed the fee paid by Customer to ]project open[ under this Agreement.

]project-open[ will not be liable for lack of economic success, lost profits, or for failure of cost reductions to materialize. ]project-open[ shall not under any circumstances be liable for the replacement of data (in the case of data loss due to a system crash, user errors etc.). Neither party shall be liable for any delay or failure resulting directly or indirectly from force majeure or any causes beyond the reasonable control of the parties.

#### 11 Imprint and Publication

Customer will allow ]project-open[ the use of the project as a customer reference in its company presentations. Customer will be given the opportunity to participate in suitable form in the imprint and in the HTML source code.



# 12 Changes in Preconditions

The Customer will be able to react to changes in underlying conditions through "change requests" in all project phases. In this case the Contractor will submit an amended or additional quotation that takes the "change request" into account. A change request may affect the scope of performance, costs and time schedule of the realization and the concept phase.

If the Contractor ascertains that preconditions for which the Contractor is not responsible but which are important for the success of the project do not prevail, the Customer must be informed about this without delay. If changes in the preconditions make the performance of the service by ]project-open[ impossible in respect of the scope of performance, costs or completion date the Customer and Contractor will agree on the further procedure on a fair basis.

Postponement of work performances that are not to be provided by the Contractor or which are caused by a larger number of correction stages or coordination processes than are assumed in this quotation, will result in a postponement of the work performances of the Contractor by an equivalent period of time. In this case the same procedure will be applied as in the case of a change request. This quotation is drawn up on the basis of a project specification and not on the basis of a detailed concept as is usual. This results in greater uncertainty for the Contractor since the work performances are not described individually in detail. Should it emerge that this results in substantial differences from the described requirements both parties will attempt to find a fair solution for the further procedure.



# 13 Appendix A: ]project-open[ "Free License" (FL)

#### 13.1 What is FL?

FLed code is "commercial software", but with a fixed license fee of €0. It allows you to use and modify the software for your internal purposes but restricts your right to redistribute the software. You need to become a "Partner" in order to redistribute the code to customers.

#### 13.2 License Terms

"We," "us," and "our" refers to ]project-open[. "You" and "your" refers to the individual or entity that wishes to use the programs from ]project-open[. "Programs" refers to the ]project-open[ software product you wish to download and use and program documentation. "License" refers to your right to use the programs under the terms of this agreement. This agreement is governed by the substantive and procedural laws of Spain. You and ]project-open[ agree to submit to the exclusive jurisdiction of, and venue in, the courts of Barcelona in any dispute arising out of or relating to this agreement.

We are willing to license the programs to you only upon the condition that you accept all of the terms contained in this agreement. Read the terms carefully. Downloading the software will imply that you accept this terms. If you are not willing to be bound by these terms, please do not download any software from this site.

#### 13.3 License Rights

This agreement grants you a nonexclusive, nontransferable limited license to use and to modify the program. If you want to redistribute or otherwise publish the program or its parts then you must contact us, or an ]project-open[ reseller, to obtain the appropriate license. We may audit your use of the programs.

#### 13.4 Ownership and Restrictions

We retain all ownership and intellectual property rights in the programs.

You may not:

- remove or modify any program markings or any notice of our proprietary rights;
- make the programs available in any manner to any third party;
- use the programs to provide third party training or hosting;
- assign this agreement or give or transfer the programs or an interest in them to another individual or entity

or,



- use any ]project-open[ name, trademark or logo.

#### 13.6 No Technical Support

Our technical support organization will not provide technical support, phone support, or updates to you for the programs licensed under this agreement. You have to close a support contract in order to receive these services.

#### 13.7 End of Agreement

You may terminate this agreement by destroying all copies of the programs. We have the right to terminate your right to use the programs if you fail to comply with any of the terms of this agreement, in which case you shall destroy all copies of the programs.

#### 13.8 Relationship Between the Parties

The relationship between you and us is that of licensee/licensor. Neither party will represent that it has any authority to assume or create any obligation, express or implied, on behalf of the other party, nor to represent the other party as agent, employee, franchisee, or in any other capacity. Nothing in this agreement shall be construed to limit either party's right to independently develop or distribute software that is functionally similar to the other party's products, so long as proprietary information of the other party is not included in such software.

#### 13.9 Open Source

"Open Source" software - software available without charge for use, modification and distribution - is often licensed under terms that require the user to make the user's modifications to the Open Source software or any software that the user 'combines' with the Open Source software freely available in source code form. If you use Open



Source software in conjunction with the programs, you must ensure that your use does not: (i) create, or purport to create, obligations of us with respect to the ]project-open[ programs; or (ii) grant, or purport to grant, to any third party any rights to or immunities under our intellectual property or proprietary rights in the ]project-open[ programs. For example, you may not develop a software program using an ]project-open[ program and an Open Source program where such use results in a program file(s) that contains code from both the ]project-open[ program and the Open Source program (including without limitation libraries) if the Open Source program is licensed under a license that requires any "modifications" be made freely available. You also may not combine the ]project-open[ program with programs licensed under the GNU General Public License ("GPL") in any manner that could cause, or could be interpreted or asserted to cause, the ]project-open[ program or any modifications thereto to become subject to the terms of the GPL.

#### 13.10 Entire Agreement

You agree that this agreement is the complete agreement for the programs and licenses, and this agreement supersedes all prior or contemporaneous agreements or representations. If any term of this agreement is found to be invalid or unenforceable, the remaining provisions will remain effective.

#### 14.6 No Technical Support

Our technical support organization will not provide technical support, phone support, or updates to you for the programs licensed under this agreement. You have to close a support contract in order to receive these services.

#### 14.7 End of Agreement

You may terminate this agreement by destroying all copies of the programs. We have the right to terminate your right to use the programs if you fail to comply with any of the terms of this agreement, in which case you shall destroy all copies of the programs.

#### 14.8 Relationship Between the Parties

The relationship between you and us is that of licensee/licensor. Neither party will represent that it has any authority to assume or create any obligation, express or implied, on behalf of the other party, nor to represent the other party as agent, employee, franchisee, or in any other capacity. Nothing in this agreement shall be construed to limit either party's right to independently develop or distribute software that is functionally similar to the other party's products, so long as proprietary information of the other party is not included in such software.

#### 14.9 Open Source
